It takes all of us to build an inclusive and safe community. Together with **Councillor James Pasternak**, I visited the Pride of Israel Synagogue to meet with the chair and vice-chair of the board to see the damage to their worship space and listen to the impact this attack has had on their congregation. I support the efforts of the Toronto Police Service to locate and charge the perpetrators.

I believe our city should take more proactive steps to promote biking as a healthy activity and transportation option. Changing human behaviour is always a challenge. 1. City Council direct the Executive Director, Environment and Climate, in partnership with the General Manager, Transportation Services, to report to Infrastructure and Environment Committee in the first quarter of 2025 on the City's existing education and engagement programs that encourage cycling lifestyle choices, and how these can be expanded upon to involve experiential public engagement and a focus on areas outside the downtown core, with proposed program costs and implementation for consideration in a future budge.

175 Cummer - PH13.5 - Modular Housing Initiative Phase 2: Update Report, and Amendments to Purchase Order Numbers 6052027 and 6052881

I wrote about this item when it came to the Planning and Housing Committee on June 13, 2024. The staff report provided an update on the modular housing projects at 175 Cummer Ave. and 39 Dundalk Dr. City Council authorized city divisions to restart and complete both projects by approving Purchase Order Amendments for each project to ensure funding is in place to complete the required work. Council also authorized the award of contracts to NRB Inc. under the Request for Proposal for modular housing design build at 175 Cummer

The modular housing project at 39 Dundalk Dr. in Scarborough is nearing completion with only landscaping and a review of cost escalations remaining. The Confidential Attachments prepared included confidential information regarding the pricing for these projects under negotiation with the City's supplier, estimated costs to complete the projects, and confidential information related to

delivery of the project at 175 Cummer Ave. Council authorized the release of these confidential attachments once the projects are complete.

Sankofa Square - Where We Landed
I must be completely honest, I was not entirely sure where I would land on this issue. I struggled because I knew the discourse had become quite divisive and moving forward without corrective actions could undermine trust in our democracy. To be clear, the vote to change the name of the square already happened. However, this motion was about the next steps which include what is most key - a plan for how to revitalize the square which has been lost in the

Despite it not being on the agenda, council could have:

- 1. Undone its previous decision to rename
- 2. Embarked on a new re-naming journey
- 3. Moved forward with Sankofa and the motion for a plan to revitalize the square.

As I said in my previous newsletter, I can understand the discomfort with the word Sankofa. For many, it sounds foreign and not easily embraced because of how new it is. I too felt similarly when I first heard the name. However, the name, especially its meaning, has grown on me. Sankofa means to retrieve things of value from our knowledge of the past.

While many lament the lack of participation in choosing the name, it is not uncommon for naming decisions to be made through council that do not include a community-wide vote. This includes the naming of the Rob Ford Stadium that happened earlier this year. While the name Sankofa did come from a committee of community representatives, the Rob Ford Stadium was put forth by my colleagues and passed without a committee or consultation.

We must remember why this all began - it was a compromise to save money. Instead of \$13 million for renaming an entire street, a few assets, including Yonge-Dundas Square were chosen to be renamed for a much lower cost. If we continue to debate and engage in a new process more money will be spent and we will also lose a critical opportunity to revitalize the square.

Over the course of the questions and speeches, it became clear to me that moving forward with the name Sankofa and the corresponding revitalization plan was the practical thing to do and the right thing to do. The divisiveness of the debate has been hurtful to members of the Black community who feel the harm and history of slavery have not been acknowledged and the discussion itself has minimized their struggles. It has also been hurtful to family members of Henry Dundas who were once proud of the legacy of their ancestor. The best thing we can do is move forward, say yes to the invitation to learn from our past and bring these learnings into the future. The Square needs much more than a new name and a new sign. Moving forward allows the city to spend time and resources on bringing back the sparkle.

Electrification of Toronto Ferries

received unanimous support:

GG14.18 Process for Award of Negotiable Request for Proposal Document Number 4053424337 for the Construction of Two New Fully Electric Ferry **Vessels** The city has 4 ferries that are aging and in need of replacement. In 2020, it was

decided that we would replace them with fully electric ferries to support the city's Net Zero goals. Since that time, the cost of replacing the ferries has continued to grow. The city originally budgeted \$25 million for 2 diesel ferries. Over the course of the procurement process, amidst a context of inflation and labour shortages, the cost of 2 fully electric ferries is now \$92 million. This does not include the cost of upgrades needed to the drydock to support the maintenance of these electric ferries as well as the charging infrastructure. On Tuesday, we moved forward on a contract with Dutch company Damen Shipyards Galati to build the ferries in Romania. Several councillors were concerned about the lack of clarity on the projected maintenance costs of the ferries because it will be new technology for our city. It was amazing to hear these ferries will be able to fully recharge within 6 minutes! They will increase our capacity to move more passengers to the islands efficiently.
